The Cabinet, acting on the advice of the Financial Services Commission and in exercise of the powers conferred by section 62 of the Financial Services Commission Act, 2001 (No. 12 of 2001), and pursuant to section 102(1) of the Securities and Investment Business Act, 2010 (No. 2 of 2010), makes these Regulations.

Citation. 1. These Regulations may be cited as the Financial Services Commission (Securities and Investment Business Fees) Regulations, 2010.

No. 2 of 2010 2. The fees specified in the Schedule shall apply in relation to the Securities and Investment Business Act, 2010.

Commencement.  
No. 2 of 2010 3. (1) Subject to sub-regulation (2), these Regulations come into force on the date that the Securities and Investment Business Act, 2010 is brought into force.

(2) The matters outlined in the third column of the Schedule shall be liable to the fees prescribed in the fourth and fifth column for the periods specified in those columns.
