#### Financial Services (Fees) (Amendment) (No. 2) Regulations, 2018

The Cabinet, acting on the advice of the Financial Services Commission and in the exercise of the powers conferred by section 62 of the Financial Services Commission Act, 2001 (No. 12 of 2001), makes the following Regulations.

Citation and Citat

(2) Regulation 2 (a) shall come into effect on the date that the Financial Services Commission (Amendment) Act, 2018 is brought into force.

(3) Regulation 2 (b) (i), (v), (vi) and (vii) shall come into effect on the date that the Banks and Trust Companies (Amendment) Act, 2018 is brought into force.

(4) Regulation 2 (b) (ii), (iii) and (iv) shall be deemed to have come into force on the  $1^{st}$  day of January, 2018.

Schedule amended.

2. The Schedule to the Financial Services (Fees) Regulations, 2010 is amended –

(a) in paragraph (a) (Financial Services Commission Act, 2001) by inserting in its appropriate section numerical order, the following:
