#### Financial Services Commission (Fees) (Amendment) Regulations, 2015

The Cabinet, acting on the advice of the Financial Services Commission and in exercise of the powers conferred by section 62 of the Financial Services Commission Act, 2001 (No. 12 of 2001), makes these Regulations:

## Citation and commencement.

1. These Regulations may be cited as the Financial Services Commission (Fees) (Amendment) Regulations, 2015 and shall come into force on 1<sup>st</sup> June, 2015.

# Principal regulations amended.

**2.** The Financial Services Commission (Fees) Regulations, 2010 (hereinafter referred to as "the principal Regulations") are amended by replacing the title thereof with the following:
