## **Update to the UK Sanctions List: Cyber Regime**

Please be advised that on 11 February 2025, the UK Government designated 8 individuals/entities under the Cyber Sanctions Regime. These sanctions target ZSERVERS, a key component of Russia's cybercrime supply chain and six of its members, as well as its UK front company, XHOST Internet Solutions LP. ZSERVERS provide vital infrastructure for cybercriminals as they plan and execute attacks against the UK.
