

UK Sanctions List

As of the 10th of September 2024, the UK Government has sanctioned 5 ships and 3 entities under the Russia regime; and 4 entities and 3 individuals under the Iran regime.

Those designated and specified are key individuals, organisations, and ships involved in Iran's military support to Russia, including those involved in ballistic missile and drone supply chains.
