On 14 April, the UK Government has designated 1 entity and 1 individual under the Iran Sanctions Regime. These sanctions target the domestic threat posed by the Iranian regime by sanctioning Iranian-backed, Swedish-based Foxtrot criminal Network and its leader, Rawa Majid, for their role in attacks against targets across Europe.
