### Update to the UK Sanctions List: Global Human Rights Regime

24 March 2025 the UK Government has designated 4 individuals under the Global Human Rights Sanctions Regime. This package targets former Sri Lankan commanders and an ex-Liberation Tigers of Tamil Eelam (LTTE) commander responsible for serious human rights violations and abuses during the civil war under the Global Human Rights Sanctions Regulation 2020.
