

UK Sanctions List

On 17 October 2024, the UK Government sanctioned 18 Oil Tankers, 4 Liquid Natural Gas (LNG) ships, and one entity under the Russia Sanctions Regime. Those specified/designated are part of/involved in Putin's shadow fleet of oil tankers which seek to circumvent sanctions on Russian Oil and Liquid Natural Gas. This action against the shadow fleet is putting grit into the system and starving Putin's war machine of crucial revenues.
